





SUBSTANCE USE DISORDER DEFINITION

- Recurrent use of alcohol and/or other drugs despite causing clinically significant impairment, including health problems, disability, and failure to meet major responsibilities at work, school, or home
- Dependence v. addiction
- On a spectrum
- No need to hit horrible bottom

- Alcohol
 - Still most used drug
 - Moderate use standards
 - 28 million active AUD
 - Liver, heart, cancers, stroke
 - Depression, sleep, accidents
 - 178K deaths/year
 - Medication
 - Medically supervised withdrawal
- Cannabis/marijuana
 - Smoke, vape, edibles
 - Increased potency
 - 50 million users per year
 - Data supports some medical uses
 - Some data about health consequences
 - Risk of psychotic symptoms
 - 3 million CUD
 - Just say “wait”

ALCOHOL AND CANNABIS

- Stimulants

- Methamphetamine, cocaine
- Amphetamines, including ADHD meds
- 10.2 million mis-used in 2022
- Overdoses increasing
- Heart and mental health risks
- No on-label medications
- Contingency management w/ CBT

- Benzodiazapenes

- Sedatives/tranquilizers
- Anxiety meds
- Examples: Xanax, Klonopin, Valium, Ativan
- 30 million users annually
- Dependence v. addiction
- Taper down
- Medically supervised withdrawal

STIMULANTS AND BENZOS

- **Opiates**
 - Heroin
 - Fentanyl
 - Oxycontin/Oxycodone
 - Codeine, Percocet, Demerol
- **Overdoses**
 - 100K+ fatal 2020-23
 - 90K fatal 2024
 - 80% opioids, stimulants increasing
 - Why?
 - Demographics
 - Harm reduction tools
 - Behavioral
 - Fentanyl test strips
 - Naloxone
 - Syringe Services
 - Overdose prevention centers
 - Medications

OPIATES



SUBSTANCE USE DISORDER RATES

- General population (GP) and Attorneys (A)
 - Alcohol use disorder, 11.8% GP, 20.6% A
 - Sedatives: 6% GP, 15.7% A
 - Marijuana: 6% GP, 10.2% A
 - Opioids: 3% GP, 5.6% A
 - Stimulants: 2% GP, 4.8% A
 - There is overlap among substances

ATTORNEY SUD EXPLANATION

Reasons:

Long Hours

High Stress

- Workload
- Traumatized Clients
- Lot at Stake for Clients

High Standards

Job Dissatisfaction

Lack of Control



Treatment Barriers

Fear of Being Found Out

Confidentiality Concerns

SUD/MENTAL HEALTH OVERLAP

SAMHSA: 25% of those with a mental health disorder also have a SUD

55%-70% of those with a SUD have another mental health disorder too

Other mental health disorder can come first

- Substance use starts as an effort to self-medicate and manage symptoms
- Mental health brain biology may make drugs more attractive

SUD can come first

Some drugs can cause psychotic symptoms

- Methamphetamine
- Marijuana
- Alcohol

These symptoms might not resolve for long time or ever

TRAUMA/SUD OVERLAP

Trauma and SUD have high percentage of overlap

- ACE of 4 increases likelihood of SUD by factor of 3
- SUD can be pain-management technique
- Trauma may underly PTSD, anxiety, and/or depression too

SUD-related activities put at risk of trauma


- Physical assault
- Sexual assault
- Being unhoused
- Incarceration

Evaluate for and treat simultaneously

- Dual diagnosis expertise
- Increases recovery odds for both



ATTORNEY DISCIPLINE AND SU

- Substance use involved in (one estimate):
 - 60% attorney discipline prosecutions.
 - 90% serious disciplinary matters.
 - 60% legal malpractice claims.



MODEL RULES OF PROFESSIONAL CONDUCT & SUD

Competence, RPC 1.1

- A lawyer shall provide competent representation to a client.
- Competent representation requires the legal knowledge, skill, thoroughness and preparation reasonably necessary for the representation.

Diligence, RPC 1.3


- A lawyer shall act with reasonable diligence and promptness in representing a client.

Communication, RPC 1.4

- Obtain informed consent
- Keep client reasonably informed
- Comply with reasonable requests for information

Conflict of Interest, RPC 1.7(b)

- Representation limited by a personal interest of the attorney



MODEL RULES OF PROF'L CONDUCT & SUD (CONT'D)

Safekeeping Property, RPC 1.15

- Including client monies

Declining or Terminating Representation, RPC 1.16


- The lawyer's mental or physical condition materially impairs the ability to represent the client

Delay of Litigation, RPC 3.2

- A lawyer shall make reasonable efforts to expedite litigation consistent with the interests of the client

Misconduct, RPC 8.4

- Commit a criminal act that reflects adversely on the honesty, trustworthiness, or fitness as a lawyer
 - DUI
 - Illegal drug use or possession



MODEL RULES OF PROF'L CONDUCT & SUD (CONT'D)

Supervisory responsibilities, RPC 5.1

- If suspect junior attorney of SUD problem that has or could result in violation of Rules

Possible SUD Signs

- Attendance
- Job performance
- Erratic behavior

Can be many other causes

Legal protections

- ADA (Americans with Disabilities Act):
- FMLA (Family Medical Leave Act)


